Implementation Measures for Promoting High-Quality Development of Urban Industry in Haizhu District of Guangzhou Municipality

Chapter I General Provisions

Article 1 In order to promote the high-quality development of modern urban industry in Haizhu District, seize the opportunities of the new round of technological revolution and industrial transformation and promote the accelerated, sustainable and innovative development of urban industry in the whole district, these Implementation Measures (hereinafter referred to as "these Measures") are formulated on the basis of the actual conditions of this District, in accordance with the *Guidelines on Accelerating the Cultivation and Development of High-quality Manufacturing Enterprises by the Ministry of Industry and Information Technology, the Ministry of Science and Technology, the Ministry of Finance, the Ministry of Commerce, the State-owned Assets Supervision and Administration Commission and the China Securities Regulatory Commission* (Gong Xin Bu Lian Zheng Fa [2021] No. 70) and the *Guidelines of the CPC Guangdong Provincial Committee and the Guangdong Provincial People's Government on Turning Guangdong Into a Manufacturing Powerhouse in a High-Quality Way*, taking the development of new quality productive forces as an important focus, accelerating the promotion of new industrialization and cultivating new industrial driving forces and growth poles.

Chapter II Application

Article 2 These Measures shall apply to industrial enterprises that are engaged in production and operating activities in Haizhu District in accordance with the law and have established sound financial systems.

Chapter III Reward Measures

Article 3 [Support for Industrial Enterprises that Upgrade to Enterprises above Designated Size for the First Time] This District increases support for the cultivation of small and micro enterprises; for industrial enterprises that upgrade to enterprises above designated size for the first time, a support of not more than 100,000 yuan will be granted.

Article 4 [Support for Accelerated Development] For every 20,000,000 yuan increase in the gross annual industrial output value of industrial enterprises compared with the previous year, a support of not more than 100,000 yuan will be granted. The maximum support received each year by the same industrial enterprise during the validity period of this clause shall not exceed 2,000,000 yuan.

Article 5 [Support for the Development of New Quality Productivity] For manufacturing enterprises that implement new industrial technology transformation investment projects, digital and intelligent transformation and upgrading projects, explore projects for optimization and upgrading of production tools and equipment, production methods and resource allocation methods, with a project investment scale of more than 5,000,000 yuan, a support of not more than 1,000,000 yuan at a rate of not more than 5% of the actual investment amount will be granted.

Article 6 [Support for Level Enhancement] For industrial enterprises that have become the national champions in specific manufacturing segments for the first time, a support of not more than 2,500,000 yuan will be granted; for industrial enterprises that have become the provincial (Guangdong Province) champions in specific manufacturing segments for the first time, a support of not more than 500,000 yuan will be granted. If multiple support standards are met by an item under the same category during the validity period of this clause, only the amount of difference to the highest level of support will be rewarded.

Article 7 [Create a Good Ecological Environment and Provide Supporting Facilities]

(1) Reward talents who contribute to the industry. This District encourages enterprises to

allocate more than 50% of the total reward funds obtained in Haizhu District to serve as subsidies for key talents. The reward funds can be transferred to the personal accounts of the key talents in a lump sum after deducting personal income taxes according to the needs of enterprises. The specific allocation plan of reward funds shall be determined independently by the enterprises. The recommendation of key talents adopts the enterprise commitment system, in which the enterprise is responsible for recommending key talents to be rewarded and incentive plans, and is responsible for their qualifications. For industrial enterprises that have been recognized as trading headquarters in Haizhu District, the children of their management personnel and talents shall be coordinated to attend the compulsory education schools in the District in accordance with relevant regulations.

(2) Strive for policies and resources at all levels. This District fully supports the construction of industrial clusters and carriers, and strives for the superposition of national, provincial and municipal high-end resources and policies for creating a high-quality development platform for the industry; strengthens the promotion and guidance of industrial support policies, and actively recommends characteristic manufacturing parks, platforms, enterprises, technological solutions and products to the State, Guangdong Province and Guangzhou Municipality.

Chapter IV Supplementary Provisions

Article 8 Enterprises applying for support under these Measures shall not be included in the list of entities with highly dishonest behaviors and shall sign relevant business commitment letters.

Article 9 Enterprises that have signed land use agreements and "One Policy for One Enterprise" agreements in the District and enjoyed relevant funding arrangements, land supply and other resource elements shall comply with the agreements and are not qualified for application as per these Measures. Where the same matter meets multiple measures herein, the measure representing the highest actual reward amount shall be implemented; if the same project or matter that complies with the provisions of these Measures as well as other support policies and regulations in the District (including policies and regulations of higher-level government sectors requiring the District to provide supporting facilities or funds), support shall be given in accordance with the principle of highest amount of subsidies for one project or matter, except as otherwise provided. The total annual reward amount under these Measures shall not exceed 25,000,000 yuan. The tax related expenses for obtaining the rewards shall be borne by the enterprise or individual. The terms "more than", "not more than" and "maximum" referred to herein shall include the given figures.

Article 10 These Measures shall come into force from the date of issuance and shall be valid until June 30, 2027. The document *Notice of Haizhu District Bureau of Science, Industry, Commerce and Information Technology of Guangzhou Municipality on Issuing the Implementation Measures for Promoting High-Quality Development of Urban Industry in Haizhu District of Guangzhou Municipality* (Hai Ke Gong Shang Xin Gui Zi [2022] No. 2), issued on July 1, 2022, shall be abolished accordingly. Where these Measures cannot be implemented due to force majeure, the acts of higher-level governments or government sectors, or the promulgation of relevant laws, regulations, rules and policies, relevant support shall be terminated. In case of any inconsistency between these Measures and the provisions of the superior laws, regulations, rules and policies due to the change of these superior laws, regulations, rules and policies, the provisions of the superior laws, regulations, rules and policies shall prevail and the corresponding provisions of these Measures shall no longer be implemented. The interpretation of these Measures shall be vested in the Haizhu District Bureau of Science, Industry, Commerce and Information Technology of Guangzhou Municipality.
